GoPlant Microsoft Active Directory (AD) feature

User settings

In order to use AD accounts and passwords with GoPlant each user must be created with a username that matches their AD username. The username must match exactly.

Admin settings

GoPlant root level Admin settings must be updated:

- 1. Ensure that Users have been added with their username that matches the AD account.
- 2. Login to GoPlant as a root level account with Administrator security role.
- 3. Navigate to the ADMIN area, and choose the GoPlant Settings from the navigation on the left-hand side:

- 4. Update the "Security Authentication Provider (goplant | ad) " to 'ad'.
- 5. Update the "Security Authentication Connection" to the LDAP URL link that will serve to authenticate your users for the Domain. This LDAP URL link will be used by the GoPlant software to validate passwords entered for the usernames. No Windows AD passwords are stored within the GoPlant database. Authentication and password matching is done entirely on the LDAP URL by Microsoft.





6. Update the "Domain Name" with the Windows domain for your users:

- 7. Press the blue 'Apply' button to save your changes.
- 8. Users may now login with their Domain and username. If no Domain is added to their username, GoPlant will use the 'Domain Name' setting to automatically add it to their username for login authentication on the LDAP server.
- 9. Users may use their Windows AD username on both the website and the GoPlant Mobile app.
